COMPLAINT FOR DECLARATORY AND INJUNCTIVE RELIEF; SUMMONS

Plaintiff REPUBLICAN NATIONAL COMMITTEE (the "RNC"), by and through its attorneys, Dhillon Law Group Inc., for a Complaint against Defendants STATE OF HAWAII, OFFICE OF ELECTIONS (the "Office") and SCOTT NAGO, in his official capacity as Chief Election Officer of the State of Hawaii ("Mr. Nago"), alleges and avers as follows:

I. INTRODUCTION

1. The RNC submitted a public records request pursuant to Hawaii's Uniform Information Practices Act ("UIPA") to Mr. Nago and the Office seeking sixteen categories of information related to the State of Hawaii's programs and practices pertaining to the maintenance



of accurate voter rolls as required by the National Voter Registration Act of 1993 ("NVRA").

- 2. Under the NVRA, states are required to permit members of the public to inspect the kinds of records the RNC requested.
- 3. When state or federal law expressly authorizes disclosure of a given record (as the NVRA does), UIPA requires that agencies disclose it to requestors.
- 4. Despite the Office's clear obligation to provide the RNC with various records related to its voter rolls, the Office refused to tell the RNC whether it possessed records responsive to the RNC's requests. Instead, the Office told the RNC's counsel to request the records from the county clerks.
- 5. The Office's response to the RNC's UIPA request violated Mr. Nago and the Office's obligations under UIPA. The Office and Mr. Nago were required to provide the RNC with responsive records in their possession unless an exception to UIPA's right of open access to government access applies.
- 6. The RNC therefore brings this action to enforce its rights under UIPA and to obtain access to the records from Mr. Nago and the Office to which it is entitled under UIPA.

II. JURISDICTION AND VENUE

- 7. This Court has jurisdiction over this matter because UIPA expressly authorizes "person[s] aggrieved by a denial of access to a government record [to] bring an action against the agency" in circuit court. Haw. Rev. Stat. §§ 92F-15(a), (e).
- 8. Venue is proper in the First Circuit because the Office's headquarters are located in the City and County of Honolulu, and, upon information and belief, the records the RNC requested are maintained in the City and County of Honolulu.

III. PARTIES

- 9. Plaintiff Republican National Committee is a national political party committee that is responsible for the strategic and day-to-day operation of the Republican Party at the national level and for promoting the election of Republican candidates for federal office in the United States, including in Hawaii. The RNC has a direct, personal, and substantial interest in ensuring that the State of Hawaii ensures the accuracy of voter rolls, including by complying with the NVRA.
- 10. Defendant State of Hawaii, Office of Elections is a state agency created to "provide support to the chief election officer." Haw. Rev. Stat. § 11-1.5(a).
- 11. Defendant Scott Nago is the Chief Election Officer of the State of Hawaii. He is named as a defendant in this action in his official capacity only. "The chief election officer shall maintain data concerning registered voters, elections, apportionment, and districting." Haw. Rev. Stat. § 11-2(c).

IV. LEGAL BACKGROUND

The NVRA

- 12. The NVRA is a federal law that sets forth various voter registration requirements that pertain to elections for federal offices.
- 13. The NVRA created various requirements for states relating to voter registration. For example, states must, among other things, adopt certain procedures relating to voter registration through motor vehicle registration, "conduct a general program that makes a reasonable effort to remove the names of ineligible voters from the official lists of eligible voters" because of death or a change in residence, and inform applicants of voter eligibility requirements and penalties for the submission of false voter registration applications. *See generally* 52 U.S.C.

§ 20507.

14. The NVRA further requires open access to records it requires states to maintain: "Each State shall maintain for at least 2 years and shall make available for public inspection and, where available, photocopying at a reasonable cost, all records concerning the implementation of programs and activities conducted for the purpose of ensuring the accuracy and currency of official lists of eligible voters, except to the extent that such records relate to a declination to register to vote or to the identity of a voter registration agency through which any particular voter is registered." 52 U.S.C. § 20507(i)(1).

Hawaii's UIPA

- 15. Hawaii's UIPA gives the public broad rights to access records maintained by government agencies.
- 16. "All government records are open to public inspection unless access is restricted or closed by law." Haw. Rev. Stat. § 92F-11(A).
- 17. "Except as provided in section 92F-13, each agency upon request by any person shall make government records available for inspection and copying during regular business hours." Haw. Rev. Stat. § 92F-11(B).
- 18. Section 92F-13 contains five exceptions to disclosure, which, upon information and belief, do not apply to the records at issue in this case.
- 19. "Government records which, pursuant to federal law or a statute of this State, are expressly authorized to be disclosed to the person requesting access." Haw. Rev. Stat. § 92F-12(b)(2).
- 20. When an agency receives a request for access to a record for which disclosure is required under HRS § 92F-12, the "agency shall disclose the record within a reasonable time not

to exceed ten business days." Hawaii Administrative Rules ("HAR") § 2-71-13(a).

- 21. "When an agency receives a request for a record that it does not maintain and reasonably believes that another agency maintains the record, the agency receiving the request shall provide a notice in accordance with section 2-71-14(c)(1)." HAR § 2-71-13(f).
- 22. Under section 2-71-14(c)(1), "[w]hen an agency is unable to disclose a record, the agency's notice shall state that the agency is unable to disclose the requested record, or part thereof, because: . . . [t]he agency does not maintain the record, and the agency may provide the name and address of another agency that, as the agency reasonably believes, may maintain the requested record." HAR § 2-71-14(c)(1).
- 23. Accordingly, an agency that possesses records responsive to a UIPA request cannot simply refuse to permit access to the records by pointing to another agency that may have the same records.

V. DEFENDANTS' VIOLATIONS OF UIPA

- 24. On March 25, 2025, the RNC, through its counsel, Dhillon Law Group Inc. ("DLG"), sent a request to Mr. Nago and the Office requesting sixteen categories of records that the RNC believes the Office must possess given its obligations under the NVRA, citing both the NVRA and state public records law (the "March 25 Request"). A true and correct copy of the March 25 Request is attached hereto as **Exhibit 1**. Broadly speaking, the March 25 Request sought records related to the types of voter registration and list maintenance activities covered by the NVRA.
- 25. The March 25 Request satisfied the requirements for a request under UIPA inasmuch as it (1) provided the RNC's legal representative's contact information; (2) contained a reasonable description of the requested records that would have enabled agency personnel to

locate them with reasonable effort; and (3) contained a request to obtain the records, including the preferred means of receiving the records. *See* HAR § 2-71-12(b).

- 26. The March 25 Request made clear that to the extent the RNC was requesting non-public voter registration information, the RNC was doing so for election purposes only as defined by HAR § 3-177-160(e).
- 27. On April 1, 2025, Raymund de Vega of the Office's Voter Services division responded to the March 25 Request as follows: "Thank you for your email. For records concerning voter registration, please contact the county clerks. Their contact information can be found at https://elections.hawaii.gov/resources/county-election-divisions/. Any further related questions may be directed to the county clerks." A true and correct copy of Mr. de Vega's email is attached hereto as **Exhibit 2**.
- Vega did not confirm whether the Office searched for the records at issue and that it would be highly unlikely for the Office not to have any of the types of records requested, such as memos, manuals, policies, emails, or voter registration data. DLG further requested that the Office confirm that it conducted a search for responsive records discussing list maintenance procedures and related list maintenance data. A true and correct copy of DLG's email is attached hereto as **Exhibit** 3.
- 29. On April 21, 2025, Mr. de Vega responded: "Thank you for your email. As it relates to your letter, dated March 25, 2024, our office is referring you to the county clerks. Their contact information can be found at https://elections.hawaii.gov/resources/county-election-divisions/. Any further related questions may be directed to the county clerks." A true and correct copy of Mr. de Vega's email is attached hereto as **Exhibit 4**.

- 30. On June 3, 2025, DLG sent a letter to Mr. de Vega explaining that his direction to seek records from the county clerks was insufficient, repeating the RNC's request for the responsive records referenced in the March 25 Request. A true and correct copy of DLG's email is attached hereto as **Exhibit 5**.
- 31. While the RNC is entitled to access records responsive to the March 25 Request that the Office and Mr. Nago maintain regardless of whether any other agencies may also maintain those records, the Counties of Kauai and Hawaii's respective responses to similar UIPA requests make clear that the RNC properly sought the records at issue from the Office and Mr. Nago.
- 32. On or about September 2, 2025, DLG spoke with an employee in the Office of the County Clerk of the County of Kauai, who directed DLG to seek the records at issue from the State. When DLG explained that the Office had directed the RNC to obtain the records from the county clerks, the employee spoke with her supervisor and then repeated her earlier instruction to request the records from the State.
- 33. On or about September 19, 2025, the County of Hawaii issued a Notice to Requester to DLG responding in part to a UIPA request that mirrored the RNC's UIPA request to the Office and Mr. Nago. The County of Hawaii's response addressed only request numbers 4, 5, 7, 11, 12, and 15. The County of Hawaii represented that it cannot disclose the records at issue because it does not maintain them. A true and correct copy of the Notice to Requester is attached hereto as **Exhibit 6**. The County of Hawaii separately provided DLG with a cost estimate to inspect and copy documents responsive to certain other requests. However, the County of Hawaii's possession of certain documents the RNC requested from the Office and Mr. Nago does not excuse the Office and Mr. Nago from complying with their obligations under the UIPA, and the fact that the County of Hawaii maintains certain records makes clear that they do indeed exist.

- 34. On or about September 29, 2025, DLG sent certifications to Mr. Nago as well as all four county clerks that certified by self-subscribing oath (1) the election purpose for which the RNC was seeking the information DLG had requested; (2) that the RNC was seeking the information for election purposes only; (3) and that that the information will not be sold, released, distributed, or used in any way for commercial purposes. True and correct copies of each of these certifications are attached hereto as **Exhibit 7**.
- 35. To date, the Office has not responded to DLG's June 3, 2025, letter or provided any further response to the March 25 Request, including any response to the September 29, 2025, certification DLG provided.
- 36. The Office and Mr. Nago have never stated whether they have records responsive to the March 25 Request nor have they agreed to permit access to any such records.
- 37. The Office and Mr. Nago's refusal to respond to the RNC's March 25 Request beyond directing the RNC to request the records at issue from the county clerks therefore violates various provisions of UIPA and its implementing regulations.
- 38. Given the Office and Mr. Nago's refusal to provide a lawful response to the March 25 Request, there is an actual and immediate controversy between the RNC, on the one hand, and the Office and Mr. Nago, on the other hand, in which both sides have genuine and opposing interests, which are direct and substantial. The RNC is therefore entitled to declaratory relief in this matter.

VI. CLAIMS FOR RELIEF

COUNT ONE

FAILURE TO PERMIT INSPECTION AND COPYING OF GOVERNMENT RECORDS (Haw. Rev. Stat. §§ 92F-11, et seq.; HAR §§ 2-71-11, et seq.) (against both Defendants)

- 39. The RNC repeats and realleges each of the foregoing paragraphs as if explicitly stated herein.
- 40. By sending the March 25 Request to Mr. Nago and the Office, the RNC sought to inspect and copy government records within the possession of Mr. Nago and the Office under UIPA.
- 41. The records the RNC sought to inspect were government records within the scope of UIPA, including, without limitation, records that are required to be disclosed under the NVRA.
- 42. Upon information and belief, the Office and Mr. Nago have records responsive to the March 25 Request in their possession.
- 43. The Office and Mr. Nago have failed to establish that they do not possess records responsive to the March 25 Request.
- 44. The Office and Mr. Nago have failed to establish that there is a statutory exception allowing them to deny the RNC permission to inspect the records requested in the March 25 Request.
- 45. The Office and Mr. Nago therefore unlawfully denied the RNC access to all records referenced in the March 25 Request.

COUNT TWO

FAILURE TO PERMIT ACCESS TO GOVERNMENT RECORDS WITHIN 10 BUSINESS DAYS (HAR § 2-71-13(a))

(against both Defendants)

- 46. The RNC repeats and realleges each of the foregoing paragraphs as if explicitly stated herein.
- 47. By sending the March 25 Request to Mr. Nago and the Office, the RNC sought to access government records within the possession of Mr. Nago and the Office under UIPA.
- 48. The records the RNC sought to access were government records within the scope of UIPA, including, without limitation, records that are required to be disclosed under the NVRA.
- 49. Upon information and belief, the Office and Mr. Nago have records responsive to the March 25 Request in their possession.
- 50. The Office and Mr. Nago have failed to establish that they do not possess records responsive to the March 25 Request.
- 51. The Office and Mr. Nago have failed to establish that there is a statutory exception allowing them to deny the RNC permission to access the records requested in the March 25 Request.
- 52. The Office and Mr. Nago failed to permit the RNC to access all records referenced in the March 25 Request within a reasonable period of time not to exceed ten business days, which constitutes a denial of access under UIPA. *See* HAR § 2-71-13(a).

COUNT THREE

FAILURE TO IDENTIFY AND JUSTIFY GOVERNMENT RECORDS BEING WITHHELD (HAR §§ 2-71-13(f); 2-71-14(b)(1-2) & (c)) (against both Defendants)

53. The RNC repeats and realleges each of the foregoing paragraphs as if explicitly stated herein.

- 54. By sending the March 25 Request to Mr. Nago and the Office, the RNC sought to access government records within the possession of Mr. Nago and the Office under UIPA.
- 55. The records the RNC sought to access were government records within the scope of UIPA, including, without limitation, records that are required to be disclosed under the NVRA.
- 56. In responding to the March 25 Request, the Office and Mr. Nago refused to permit access to any records without confirming whether they had records responsive to the March 25 Request in their possession, without identifying the records to which they would be denying access, and without identifying the legal authorities under which they would be denying the RNC access to the records.
- 57. The Office and Mr. Nago therefore violated HAR 2-71-14(b), which contains the following requirement: "When the agency intends to deny access to all or part of the information in the requested record, the agency's notice to the requester shall state: . . . (1) [t]he specific record or parts of the record that will not be disclosed; and (2) [t]he specific legal authorities under which the request for access is denied under section 92F-13."
- 58. Mr. de Vega's repeated direction to the RNC that it seek the requested records from the county clerks is insufficient as a matter of law because an agency may only satisfy its obligations under UIPA by providing "the name and address of another agency that, as the agency reasonably believes, may maintain the requested record" when its notice also states that it does not maintain the record, which Mr. de Vega did not state in his two emails to DLG. *See* HAR §§ 2-71-13(f); 2-71-14(c)(1).
- 59. Upon information and belief, Mr. de Vega did not state that the Office does not have records responsive to the March 25 Request in his correspondence with DLG because the Office and Mr. Nago do in fact possess records responsive to the March 25 Request.

VII. PRAYER FOR RELIEF

WHEREFORE, Plaintiff Republican National Committee prays that the Court grant the

following relief:

A. For judgment in its favor and against both Defendants on all claims alleged herein;

B. For a declaratory judgment stating that Defendants violated UIPA and its implementing

regulations by (1) failing to permit the RNC to inspect and copy all records referenced in

the March 25 Request; (2) failing to permit the RNC to access such records within 10

business days; and (3) failing to identify the records they refused to let the RNC access

and provide a justification for their refusal.

C. For preliminary and permanent injunctive relief ordering Defendants to grant the RNC the

ability to inspect and copy all records referenced in the March 25 Request;

D. For an award of the RNC's attorney's fees and costs pursuant to HRS § 92F-15(d) and as

otherwise permitted by law; and

E. For such other relief that the Court may deem just and proper.

Dear Chief Election Officer:

This firm represents the Republican National Committee ("RNC"). As you know, RNC is committed to a fair electoral process that ensures both access to the ballot and election integrity. Public confidence in the administration of our elections is critical to our democracy.

The starting block for voter participation and election integrity is voter registration. RNC and state and local Republican parties assist thousands of citizens each year to register to vote and devote substantial resources to get-out-the-vote efforts in reliance upon public voter registration lists. RNC also monitors elections to ensure accurate results and public confidence in election outcomes. All of these efforts rely upon accurate voter rolls. Accordingly, RNC supports state and federal laws and practices to keep voter registration rolls up to date.

Because RNC's voter registration drives, get-out-the-vote drives, and election integrity efforts depend upon the processes implemented by each state to ensure its voter rolls are accurate, RNC is conducting a review of each state's programs and practices for maintaining accurate voter rolls. As part of that review, RNC is requesting records concerning your state's programs and practices to maintain accurate voter rolls pursuant to the National Voter Registration Act ("NVRA"), 52 U.S.C. § 20507(i), as well as all applicable freedom of information laws and election transparency laws of your state.

The NVRA contains a public records provision. It requires that "[e]ach state shall maintain for at least 2 years and shall make available for public inspection . . . all records concerning the implementation of programs and activities conducted for the purpose of ensuring the accuracy and currency of official lists of eligible voters." *Id.* § 20507(i)(1). The

scope of records required to be maintained by each state is "sweeping" and includes records of all "voter list registration and maintenance activities." *United States v. Dion*, 37 F.4th 31, 35 (1st Cir. 2022). These documents must be made available upon request.

Accordingly, RNC respectfully requests the following public records: 1

- 1. Each record setting forth, documenting, describing, or discussing the programs and activities conducted in your state for the purpose of ensuring the accuracy and currency of official lists of eligible voters from March 2023 to the time of your response to this request.
- 2. From March 2023 until the time of your response to this request, each record identifying, documenting or discussing the names of the voters removed from your state's voter rolls as a result of:
 - (a) death;
 - (b) relocation (i.e., change of address);
 - (c) criminal conviction;
 - (d) non-citizenship;
 - (e) duplicate registrations for the same voter;
 - (f) administrative error;
 - (g) non-voting (i.e., inactive) for a period of years; or
 - (h) failure to respond to a mailed or public cancellation notice.
- 3. Each record that lists or identifies persons <u>sent an address confirmation</u> in your state for voter registration purposes from March 2023 until the date of your response to this request.
- 4. Each record that lists or identifies persons sent an address confirmation who **responded to the notice** from March 2023 until the time of your response to this request.
- 5. Each record that lists or identifies persons sent an address confirmation who did <u>not</u> respond to the notice from March 2023 until the time of your response to this request.
- 6. Each record that lists or identifies <u>inactive voters</u> from March 2023 until the date of your response to this request.

For purpose of this request, a "record" is defined as any document or information, in electronic form or paper copy form, and includes policies, procedures, manuals, memoranda, audits, guidance, lists, spreadsheets, data, and communications (including emails, text messages, and letters). "Record" also includes documents, information, and data found within your statewide voter registration system, the database through which your state carries out its voter list registration and maintenance activities. *See Pub. Int. Legal Found. v. Bellows*, 92 F.4th 36, 47 (1st Cir. 2024).

- 7. Each record that lists or identifies persons sent a voter registration **cancellation notice** from March 2023 until the time of your response to this request.
- 8. From March 2023 until the time of your response to this request, each record utilizing, documenting or discussing information about <u>deceased</u> voters for the purpose of updating voter registrations exchanged between your office and the following offices:
 - (a) State Department of Health;
 - (b) State Department of Corrections;
 - (c) State Department of Motor Vehicles;
 - (d) State Judiciary (including court clerks);
 - (e) U.S. Social Security Administration;
 - (f) U.S. Postal Service:
 - (g) U.S. Citizenship & Immigration Service;
 - (h) U.S. Department of Homeland Security (or any agency of the Department);
 - (i) U.S. Judiciary System (including court clerks); and
 - (j) U.S. Department of Justice (or any agency of the Department).
- 9. From March 2023 until the time of your response to this request, each record utilizing, documenting or discussing information about **relocated** (i.e., change of residence) voters for the purpose of updating voter registrations exchanged between your office and the following offices:
 - (a) State Department of Health:
 - (b) State Department of Corrections;
 - (c) State Department of Motor Vehicles:
 - (d) State Judiciary (including court clerks);
 - (e) U.S. Social Security Administration;
 - (f) U.S. Postal Service;
 - (g) U.S. Citizenship & Immigration Service:
 - (h) U.S. Department of Homeland Security (or any agency of the Department);
 - (i) U.S. Judiciary System (including court clerks); and
 - (i) U.S. Department of Justice (or any agency of the Department).
- 10. From March 2023 until the time of your response to this request, each record utilizing, documenting or discussing information about voters **convicted of a crime** for the purpose of updating voter registrations exchanged between your office and the following offices:
 - (a) State Department of Health;
 - (b) State Department of Corrections:
 - (c) State Department of Motor Vehicles;

- (d) State Judiciary (including court clerks);
- (e) U.S. Social Security Administration;
- (f) U.S. Postal Service;
- (g) U.S. Citizenship & Immigration Service;
- (h) U.S. Department of Homeland Security (or any agency of the Department);
- (i) U.S. Judiciary System (including court clerks); and
- (j) U.S. Department of Justice (or any agency of the Department).
- 11. From March 2023 until the time of your response to this request, each record utilizing, documenting or discussing information about the **non-citizenship** of voters for the purpose of updating voter registrations exchanged between your office and the following offices:
 - (a) State Department of Health;
 - (b) State Department of Corrections;
 - (c) State Department of Motor Vehicles;
 - (d) State Judiciary (including court clerks);
 - (e) U.S. Social Security Administration;
 - (f) U.S. Postal Service;
 - (g) U.S. Citizenship & Immigration Service;
 - (h) U.S. Department of Homeland Security (or any agency of the Department);
 - (i) U.S. Judiciary System (including court clerks); and
 - (j) U.S. Department of Justice (or any agency of the Department).
- 12. Each record utilizing, documenting, or discussing any of the following databases/systems/centers for the purpose of identifying deceased, relocated, criminally convicted, duplicate-registered, non-voting, or non-citizen voters and updating your state's voter registration list from March 2023 until the time of your response to this request:
 - (a) National Change of Address database;
 - (b) Systematic Alien Verification for Entitlements database:
 - (c) Electronic Registration Information Center;
 - (d) Social Security Death Index; and
 - (e) National Association of Public Health Statistics and Information System.
- 13. Each record utilizing, documenting, or discussing the use or comparison of the voter registration list to **potential juror questionnaires or jury pool records** from March 2023 until the time of your response to this request.
- 14. Each record exchanged between your office and <u>other state officials or state</u> <u>agencies</u> discussing or identifying deceased, relocated, criminally convicted, duplicate-registered, non-voting, or non-citizen voters for the purpose of updating your state's voter registration list from March 2023 until the time of your response

to this request.

- 15. From March 2023 until the time of your response to this request, each record exchanged between your office and a **county/city/town** voter registration official transmitting or discussing:
 - (a) Instructions to the county/city/town concerning their voter list maintenance practices and responsibilities;
 - (b) Instructions to the county/city/town for the identification and removal of noncitizens;
 - (c) Instructions to the county/city/town for the identification and removal of deceased voters:
 - (d) Instructions to the county/city/town for the identification and removal of voters who changed residences;
 - (e) Instructions to the county/city/town for the identification and removal of convicted felons:
 - (f) Instructions to the county/city/town for the identification and removal of voters who are registered to vote in more than one jurisdiction;



RNC and state and local Republican parties assist thousands of citizens each year to register to vote and devote substantial resources to get-out-the-vote efforts in reliance upon public voter registration lists. RNC also monitors elections to ensure accurate results and public confidence in election outcomes. All of these efforts rely upon accurate voter rolls. Accordingly, RNC supports state and federal laws and practices to keep voter registration rolls up to date.

Because RNC's voter registration drives, get-out-the-vote drives, and election integrity efforts depend upon the processes implemented by each state to ensure its voter rolls are accurate, RNC is conducting a review of each state's programs and practices for maintaining accurate voter rolls. Because the State of Hawaii conducts its list maintenance procedures at the county level, RNC is requesting records concerning your county's programs and practices to maintain accurate voter rolls pursuant to the National Voter Registration Act ("NVRA"), 52 U.S.C. § 20507(i), as well as all applicable freedom of information laws and election transparency laws of your state.

The NVRA contains a public records provision. It requires that "[e]ach state shall maintain for at least 2 years and shall make available for public inspection . . . all records concerning the implementation of programs and activities conducted for the purpose of

ensuring the accuracy and currency of official lists of eligible voters." *Id.* § 20507(i)(1). The scope of records required to be maintained by each state is "sweeping" and includes records of all "voter list registration and maintenance activities." *United States v. Dion*, 37 F.4th 31, 35 (1st Cir. 2022). These documents must be made available upon request.

Accordingly, RNC respectfully requests the following public records:1

- 1. Each record setting forth, documenting, describing, or discussing the programs and activities conducted in your county for the purpose of ensuring the accuracy and currency of official lists of eligible voters from August 2023 to the time of your response to this request.
- 2. From August 2023 until the time of your response to this request, each record identifying, documenting or discussing the names of the voters removed from your county's voter rolls as a result of:
 - (a) death;
 - (b) relocation (i.e., change of address);
 - (c) criminal conviction;
 - (d) non-citizenship;
 - (e) duplicate registrations for the same voter;
 - (f) administrative error;
 - (g) non-voting (i.e., inactive) for a period of years; or
 - (h) failure to respond to a mailed or public cancellation notice.
- 3. Each record that lists or identifies persons <u>sent an address confirmation</u> in your county for voter registration purposes from August 2023 until the date of your response to this request.
- 4. Each record that lists or identifies persons sent an address confirmation who **responded to the notice** from August 2023 until the time of your response to this request.
- 5. Each record that lists or identifies persons sent an address confirmation who did <u>not</u> respond to the notice from August 2023 until the time of your response to this request.
- 6. Each record that lists or identifies <u>inactive voters</u> from August 2023 until the date

For purpose of this request, a "record" is defined as any document or information, in electronic form or paper copy form, and includes policies, procedures, manuals, memoranda, audits, guidance, lists, spreadsheets, data, and communications (including emails, text messages, and letters). "Record" also includes documents, information, and data found within your voter registration system, the database through which your county carries out its voter list registration and maintenance activities. *See Pub. Int. Legal Found. v. Bellows*, 92 F.4th 36, 47 (1st Cir. 2024).

- 7. Each record that lists or identifies persons sent a voter registration **cancellation notice** from August 2023 until the time of your response to this request.
- 8. From August 2023 until the time of your response to this request, each record utilizing, documenting or discussing information about <u>deceased</u> voters for the purpose of updating voter registrations exchanged between your office and the following offices:
 - (a) State Department of Health;
 - (b) State Department of Corrections;
 - (c) State Department of Motor Vehicles;
 - (d) State Judiciary (including court clerks);
 - (e) U.S. Social Security Administration;
 - (f) U.S. Postal Service;
 - (g) U.S. Citizenship & Immigration Service;
 - (h) U.S. Department of Homeland Security (or any agency of the Department);
 - (i) U.S. Judiciary System (including court clerks); and
 - (j) U.S. Department of Justice (or any agency of the Department).
- 9. From August 2023 until the time of your response to this request, each record utilizing, documenting or discussing information about **relocated** (i.e., change of residence) voters for the purpose of updating voter registrations exchanged between your office and the following offices:
 - (a) State Department of Health;
 - (b) State Department of Corrections;
 - (c) State Department of Motor Vehicles:
 - (d) State Judiciary (including court clerks);
 - (e) U.S. Social Security Administration;
 - (f) U.S. Postal Service:
 - (g) U.S. Citizenship & Immigration Service;
 - (h) U.S. Department of Homeland Security (or any agency of the Department);
 - (i) U.S. Judiciary System (including court clerks); and
 - (j) U.S. Department of Justice (or any agency of the Department).
- 10. From August 2023 until the time of your response to this request, each record utilizing, documenting or discussing information about voters **convicted of a crime** for the purpose of updating voter registrations exchanged between your office and the following offices:
 - (a) State Department of Health;
 - (b) State Department of Corrections;

- (c) State Department of Motor Vehicles;
- (d) State Judiciary (including court clerks);
- (e) U.S. Social Security Administration;
- (f) U.S. Postal Service;
- (g) U.S. Citizenship & Immigration Service;
- (h) U.S. Department of Homeland Security (or any agency of the Department);
- (i) U.S. Judiciary System (including court clerks); and
- (j) U.S. Department of Justice (or any agency of the Department).
- 11. From August 2023 until the time of your response to this request, each record utilizing, documenting or discussing information about the **non-citizenship** of voters for the purpose of updating voter registrations exchanged between your office and the following offices:
 - (a) State Department of Health;
 - (b) State Department of Corrections;
 - (c) State Department of Motor Vehicles;
 - (d) State Judiciary (including court clerks);
 - (e) U.S. Social Security Administration;
 - (f) U.S. Postal Service:
 - (g) U.S. Citizenship & Immigration Service;
 - (h) U.S. Department of Homeland Security (or any agency of the Department);
 - (i) U.S. Judiciary System (including court clerks); and
 - (j) U.S. Department of Justice (or any agency of the Department).
- 12. Each record utilizing, documenting, or discussing any of the following databases/systems/centers for the purpose of identifying deceased, relocated, criminally convicted, duplicate-registered, non-voting, or non-citizen voters and updating your county's voter registration list from August 2023 until the time of your response to this request:
 - (a) National Change of Address database:
 - (b) Systematic Alien Verification for Entitlements database;
 - (c) Electronic Registration Information Center;
 - (d) Social Security Death Index; and
 - (e) National Association of Public Health Statistics and Information System.
- 13. Each record utilizing, documenting, or discussing the use or comparison of the voter registration list to **potential juror questionnaires or jury pool records** from August 2023 until the time of your response to this request.
- 14. Each record exchanged between your office and <u>state officials or state agencies</u> discussing or identifying deceased, relocated, criminally convicted, duplicate-registered, non-voting, or non-citizen voters for the purpose of updating your

county's voter registration list from August 2023 until the time of your response to this request.

- 15. From August 2023 until the time of your response to this request, each record exchanged between your office and any other **county/city/town** voter registration official transmitting or discussing:
 - (a) Instructions to the county/city/town concerning their voter list maintenance practices and responsibilities;
 - (b) Instructions to the county/city/town for the identification and removal of noncitizens;
 - (c) Instructions to the county/city/town for the identification and removal of deceased voters:
 - (d) Instructions to the county/city/town for the identification and removal of voters who changed residences;
 - (e) Instructions to the county/city/town for the identification and removal of convicted felons:
 - (f) Instructions to the county/city/town for the identification and removal of voters who are registered to vote in more than one jurisdiction;
 - (g) Instructions to the county/city/town for the identification and removal of voters who have not voted in successive elections;
 - (h) Notices to the county/city/town concerning any failure to comply with its voter list maintenance obligations under your state's or county's program or law; and
 - (i) Records from a county/city/town reporting on the locality's implementation of a program to identify and remove from the voter registration list those voters who are ineligible, deceased, relocated, felons, registered in more than one location, or noncitizens.
- 16. Each record that is or mentions a complaint, message, report, study, notice, email, or other communication (electronic form or paper form) your office has received discussing <u>voter roll inaccuracies</u>, and each record documenting your office's <u>corrective action or response</u> to each complaint, message, report, notice, email, or other communication.

When providing records, data, or lists identifying voters in response to any request above, we request all information identifying each voter contained within your record, including but not limited to each voter's name, voter identification number/identifier assigned by your voter registration system, address, date of birth, age, and gender. You should not exclude or redact any of this identifying information if it is contained within your records or data.

As you may be aware, the NVRA's public records disclosure provision preempts any purported public records law exemptions of your state preventing the disclosure or inspection of the requested records related to your county's voter registration list and list

maintenance practices. 52 U.S.C. § 20507(i). If you intend to assert exemptions under the NVRA, please provide a log identifying which exemptions you believe apply and what records those exemptions implicate, and provide a detailed explanation of why you believe those exemptions are applicable to each record. If you contend for any reason that the NVRA does not apply to a record, then please provide a log identifying any exemption you believe applies to specific records pursuant to your state freedom of information law.

If there are any fees for searching, copying, compiling or transmitting these records, please inform me if the cost will exceed \$500 prior to incurring the expense. However, you should not charge any fees because the disclosure of the requested information furthers a significant public interest in the transparency of election administration and will contribute to the public's understanding of, and confidence in, your state's efforts to ensure free and fair elections. This information is not being sought for commercial purposes.
