### **MESSAGING: Republicans are winning the election integrity fight**

- The Republican National Committee (RNC) is leading the fight for election integrity and we had huge wins in 2021.
  - On the legal front, we are defeating Democrats in lawsuits in states like Florida and Arizona – including a Supreme Court win in *Brnovich v. DNC*.
  - On the communications front, we've flooded the airwaves at every level and Americans support commonsense election integrity reforms, which is reflected in polling.
  - On the political front, we've hired 15 in-state election integrity directors. We also had statewide boots on the ground in the recent Virginia election, which went smoothly.

## NUMBERS DON'T LIE: Polling shows that Americans support GOP election integrity policy

- [68 percent](#) of voters believe that state legislatures should decide the voting rules and regulations for their state, not the federal government.
- Poll after poll confirms that Americans support voter ID laws as a commonsense measure for election integrity.
- [Rasmussen Reports poll](#): 69 percent of black voters and 75 percent overall support voter ID laws.
- [Honest Elections Project poll](#): Support for voter ID laws has risen 13 percentage points among Black Americans and has been shown to stand as high as 81 percent among all voters.
- [Monmouth University poll](#): 80 percent of Americans, including 62 percent of Democrats, support voter ID.
- [NPR/PBS Newshour/Marist poll](#): 79 percent of Americans support voter ID.
- [Fox News poll](#): 77 percent of Americans support voter ID.
- And a [Republican National Committee poll](#) found that:
  - 80 percent of voters support voter ID.
  - 87 percent of voters are against ballot trafficking.
  - 78 percent of all voters endorse a proposed voting plan with these five common sense measures: presenting voter ID, signature verification, chain of custody controls, bipartisan observers, and cleaning up voter rolls.

Come 2022, we're going to work to get our message out and ensure that these numbers go up even higher.

## **WINS ACROSS THE BOARD: RNC legal & political teams got results in 2021**

### **AZ: Brnovich v DNC**

In *Brnovich v. DNC*, Democrats asked the Supreme Court to transform the Voting Rights Act into a blank check that would allow for courts to strike down ordinary election laws without limit. Because of legal expertise and top tier resources from the RNC, NRCC and the NRSC, Democrats failed.

### **AZ: Signature Verification Deadline**

This month the 9<sup>th</sup> Circuit Court of Appeals decided to uphold a Republican-supported law in Arizona requiring signature curing deadlines for mail-in ballots, marking a major win for election integrity and Arizona voters.

### **FL: Ballot Harvesting**

In Florida, the RNC has intervened in four lawsuits challenging numerous provisions of SB 90, which created important election integrity safeguards. Most recently the RNC has [prevailed](#) over a left-wing attack on the ballot harvesting ban in SB 90.

### **MI: Absentee Ballot Application Harvesting**

In Michigan, the RNC is continuing its battle against a Democrat SuperPac that sued to strike down state laws banning absentee ballot application harvesting and paid "busing" to the polls. The RNC led efforts to keep laws in effect for the November 2020 election after the Democrat Attorney General gave up. The RNC recently won an important ruling at the 6th Circuit Court of Appeals upholding the busing ban and to date have beat Democrats on both of their challenges.

### **VA: Smooth Election**

The RNC was actively engaged in litigation in Virginia ensuring transparency in the administration of the November elections. We engaged over 500 attorneys on Election Day, held over 50 election integrity trainings with over 3,200 attendees, scheduled over 3,400 early voting poll-watching shifts, and invested hundreds of thousands of dollars in election integrity staff and operations.

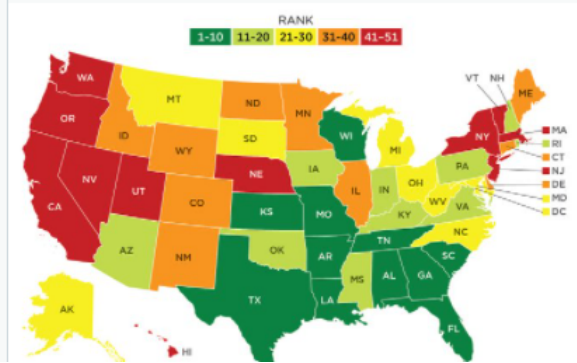
